

The demodulated output signal can directly be decoded by a microprocessor. The main benefit of the TSOP581.. is the compatibility to all kind of dataformats.










Figure 1. Output Function




Figure 2. Pulse Length and Sensitivity in Dark Ambient




Figure 3. Output Function




Figure 4. Output Pulse Diagram




Figure 5. Frequency Dependence of Responsivity





Figure 6. Sensitivity in Bright Ambient




Figure 10. Relative Spectral Sensitivity vs. Wavelength




Figure 8. Max. Envelope Duty Cycle vs. Burstlength




Figure 9. Sensitivity vs. Ambient Temperature




Figure 11. Horizontal Directivity ϕ_x




Figure 12. Vertical Directivity $\phi_{\textbf{y}}$





Suitable Data Format

The circuit of the TSOP581.. is designed in that way that unexpected output pulses due to noise or disturbance signals are avoided. A bandpass filter, an integrator stage and an automatic gain control are used to suppress such disturbances.

The distinguishing mark between data signal and disturbance signal are carrier frequency, burst length and duty cycle.

The data signal should fulfill the following conditions:

• Carrier frequency should be close to center frequency of the bandpass (e.g. 38 kHz).

• Burst length should be 6 cycles/burst or longer.

• After each burst which is between 6 cycles and 70 cycles a gap time of at least 10 cycles is necessary.

• For each burst which is longer than 1.8 ms a corresponding gap time is necessary at some time in the data stream. This gap time should have at least same length as the burst.

• Up to 2200 short bursts per second can be received continuously.

Some examples for suitable data format are: NEC Code (repetitive pulse), NEC Code (repetitive data), Toshiba Micom Format, Sharp Code, RC5 Code, RC6 Code, R-2000 Code, Sony Code, RECS-80 Code.

When a disturbance signal is applied to the TSOP581.. it can still receive the data signal. However the sensitivity is reduced to such a level that no unexpected pulses will occur.

Some examples for such disturbance signals which are suppressed by the TSOP581.. are:

• DC light (e.g. from tungsten bulb or sunlight)

• Continuous signal at 38 kHz or at any other frequency





Figure 13. IR Signal from Fluorescent Lamp with low Modulation

• Signals from fluorescent lamps with electronic ballast (an example of the signal modulation is shown in Figure 13).
