## Silicon PIN Photodiode

### Description

BP104 is a high speed and high sensitive PIN photodiode in a miniature flat plastic package. Its top view construction makes it ideal as a low cost replacement of TO-5 devices in many applications. The epoxy package itself is an IR filter, spectrally matched to GaAs or GaAs on GaAlAs IR emitters ( $\lambda_p$ =950nm). The large active area combined with a flat case gives a high sensitivity at a wide viewing angle.




