


IR Receiver Modules for Remote Control Systems

Description

The TSOP311.. - series are miniaturized receivers for infrared remote control systems. PIN diode and preamplifier are assembled on lead frame, the epoxy package is designed as IR filter.

The demodulated output signal can directly be decoded by a microprocessor. The main benefit is the operation with short burst transmission codes and high data rates at a supply voltage of 3 V.










Figure 1. Output Function




Figure 4. Output Pulse Diagram




Figure 2. Pulse Length and Sensitivity in Dark Ambient




Figure 5. Frequency Dependence of Responsivity




Figure 3. Output Function




Figure 6. Sensitivity in Bright Ambient






Figure 7. Sensitivity vs. Supply Voltage Disturbances




Figure 10. Sensitivity vs. Ambient Temperature




Figure 8. Sensitivity vs. Electric Field Disturbances




Figure 11. Relative Spectral Sensitivity vs. Wavelength




Figure 9. Max. Envelope Duty Cycle vs. Burstlength




Figure 12. Horizontal Directivity ϕ_{X}






Figure 13. Vertical Directivity ϕ_{V}




Figure 14. Sensitivity vs. Supply Voltage

Suitable Data Format

The circuit of the TSOP311.. is designed in that way that unexpected output pulses due to noise or disturbance signals are avoided. A bandpass filter, an integrator stage and an automatic gain control are used to suppress such disturbances.

The distinguishing mark between data signal and disturbance signal are carrier frequency, burst length and duty cycle.

The data signal should fulfill the following conditions:

- Carrier frequency should be close to center frequency of the bandpass (e.g. 38 kHz).
- Burst length should be 6 cycles/burst or longer.
- After each burst which is between 6 cycles and 70 cycles a gap time of at least 10 cycles is necessary.
- For each burst which is longer than 1.8 ms a corresponding gap time is necessary at some time in the data stream. This gap time should have at least the same length as the burst.
- Up to 2200 short bursts per second can be received continuously.

Some examples for suitable data formats are: NEC Code, RC5 Code, RC6 Code, RCMM Code, RECS-80 Code, R-2000 Code, Sony Code, Mitsubishi Code. When a disturbance signal is applied to the TSOP311.. it can still receive the data signal. However the sensitivity is reduced to that level that no unexpected pulses will occur.

Some examples for such disturbance signals which are suppressed by the TSOP311.. are:

- DC light (e.g. from tungsten bulb or sunlight)
- Continuous signal at 38 kHz or at any other frequency




Figure 15. IR Signal from Fluorescent Lamp with low Modulation





Figure 16. IR Signal from Fluorescent Lamp with high Modulation

- Signals from fluorescent lamps with electronic ballast with high or low modulation (see Figure 15 or Figure 16).
